Home Star Talking Points

- Introduce yourself and where you're from and ask to speak with the person who advises the Senator on energy policy
- Once connected, re-introduce yourself, where you're from, and describe your business
- Ask if the Senator is aware of the proposed Home Star program for residential energy efficiency retrofits
 - Give a quick summary of bill: \$6 billion dollars over 2 years for residential energy efficiency retrofits, and there would be 2 programs: Silver Star for rebates for installed efficiency measures and Gold Star for verified energy savings.
 - Let them know that they can request a copy of the full legislation from Deborah Estes at Senator Bingaman's office
- Explain how this bill would impact your business – Could you hire more employees?
- Ask if they know how the Senator will vote on Home Star
 - If they don't know, ask how and when you can find out – Do you have to contact them again? Will they contact you?
 - Let them know you would like the Senator to vote Yes
- Ask them if they have any questions of you
- Make sure they have your contact information and know you want to know how the Senator will vote
